Dr. Leslie Hammond, president of Artistic Eye Fine Art Services, is a fine arts consultant and Accredited Senior Appraiser of Fine Arts as well as an art historian, archaeologist and museum professional. Dr. Hammond holds a Bachelor's of Art History from The Ohio State University, a master's in Classical Archaeology from Indiana University, and a Ph.D. from the University of Missouri in Art History and Archaeology, and a minor in Museum Studies. Leslie has in excess of two decades' experience in public and private museums researching, publishing and caring for collections, curating exhibitions, presenting lectures and programs as well as acting as a juror and/or judge of art fairs, shows, exhibitions and special projects. She also has taught diverse courses in the arts and humanities, and field experiences include survey and excavation work as well as architectural drafting and artifact illustration posts in Greece, Cyprus and Egypt.

Victoria Billig is assistant director of museum operations at the Appleton Museum of Art. She earned an M.S. in Interdisciplinary Arts from Nova Southeastern University, and a Graduate Certificate in Museum Studies and B.A. in Art History from the University of South Florida. Prior to joining the Appleton Museum of Art, she held positions at the Pelham Art Center in Pelham, New York, the NSU Museum of Art in Fort Lauderdale, and the USF Contemporary Art Museum in Tampa. She sits on the board of the Magnolia Art Xchange, an incubator for emerging artists, and is a member of Marion County's Tourist Development Council. Victoria has juried art festivals and exhibitions and served as a grant panelist for organizations across the United States.

Tenee' Hart is an "unconventional" fiber sculpture artist pursuing themes of feminism that delve into topics of beauty, anatomy, and the inequality of women. Wrapped fibers, gushing forms, and the manipulation of the "everyday" are crucial components within Hart's works. Her abstract forms remain committed to an intriguing physicality that comes from palpable and intentional material usage. Hart hails from Virginia, where she received her Bachelor of Arts degree from the University of Mary Washington in 2011. Later, Hart earned her Masters of Fine Arts degree from Florida State University, where she has been teaching, at the college level, since the completion of her degree in 2015. Beyond her role as an educator, Hart is the sole Graduate Advisor + Coordinator for the Department of Art at FSU.









Susan Lenz

Susan Lenz describes herself as the daughter of German immigrants, a soul mate of a wife, a failed mother, a frustrated homeowner, an involuntary business woman, an avid traveler, a custom picture framer and taxpayer out of necessity, a non-practicing Catholic, a member of a few nonprofit organizations, a college graduate, a blogger, and the servant to an adorable cat. Yet, she is first and foremost, an artist. Using needle and thread for self-expression, Susan works within the scope of an overall theme and toward a final, mixed media installation. She stitches both by hand and machine but also indulges a passion for book arts and unique, 3D found art objects.







Brittany Metz

Brittany Metz is an installation and new media artist creating work through self-awareness that encourages introspection and contemplation. The short, cyclical nature of her video work is meditative, allowing the viewer to discover connections to the images presented through each cycle. Much of her video work includes unidentified human forms. Rather than having a specific living being, Metz chooses to blur the figures or use a prop as a placeholder for *any body*. This looping of multilayered video is somewhat disorienting, leaving the viewer questioning the time or place of her dreamlike spaces and most importantly, their place in this space. Metz received a B.A. in Studio Art from Rollins College and an M.F.A. in Emerging Media: Studio Art & the Computer from the University of Central Florida. She has exhibited nationally and internationally. Metz lives and works in Orlando, Florida, where she is a professor of Art & Design.





Kimberly Riner

Statesboro, Georgia, based artist Kimberly Riner creates mixed-media ceramic installations exploring death and mortality. Reinterpreting the vanitas genre – a genre that flourished in the Netherlands in the late 16th and early 17th centuries as a metaphor for the meaninglessness of earthly life and transient nature of earthly goods and pursuits. Translated from the Latin word meaning vanity, hallmarks of this artistic genre include depicting symbols associated with death and the futility of earthly pleasures. Riner is the visual arts director of Averitt Center for the Arts, and received her Master of Fine Art from Georgia Southern University in 3D Art with an emphasis in ceramics. Riner currently is a lecturer at Georgia Southern University and faculty at Ogeechee Technical College. Her artwork has been exhibited both nationally and internationally and is held in private collections.




































PORTABLE WALL FORMATION (LONG AND SHORT SIDES)
